### I. EXECUTIVE SUMMARY

Tappe has completed our existing conditions verifications and fieldwork related to survey, geo-tech and traffic. In addition, the team completed the educational visioning workshops and consolidated notes which has prepared the district for the creation of the educational program. Late in June Tappe received the laser verified building model which has allowed us to go deeper in our understanding of the building. In June we also started the working group meetings and establishing rhythms and structure for those.


### IV. 30-DAY LOOK AHEAD

The laser scanned model was instrumental for us to begin this work and it is now well underway. Simultaneously, Tappe is developing a series of community outreach videos that will become a series focused on educating the community about the High School and the various needs that exist in the building. The first video will be released in mid-July with follow-up releases every 3-4 weeks. August will continue option development and educational program completion. We are pushing for completion of the "PDP" phase in early fall so that we can launch directly into option refinement later in the fall and hopefully narrowing in on the preferred option in the winter.
