Along with optioning exercises we have been working to further understand the full existing conditions of the building, which will play into which options are feasible. The design team has been meeting with the working groups. One highlight is developing community outreach content which is ongoing with the next release scheduled for early fall. Additionally, working group efforts that we are focusing on are the teaching and learning tech group that is focused on the educational program document. The facilities assessment group and sustainability group are both working on the OPR (Owner's Project Requirements) document which includes a basis of design narrative.
