I. EXECUTIVE SUMMARY

The month of September was busy pulling together various options based on the strategies presented at the September building committee meeting. We have continued to meet with the district and school admin to understand the space summary as well as review the educational program for the high school. Tappe has over 10 options of various scopes. In addition, the team prepared for our first community listening sessions at the beer garden event. While it was postponed one week, this was a good event where the team had 20-30 conversations about the high school project and handed out tiny 3D models of the existing school with QR codes that allow people to visit the project site. Thus far, the QR code has been used to access the site nearly 50 times.

IV. 30-DAY LOOK AHEAD


